



Student Social Media and Device Agreement

To use a device during the allocated **Homework time only**:

- Students, Parents & **Responsible Person** must read and sign the Student Agreement together, clarifying any questions that may arise.
- Must meet the new **Safe Search Device Requirements**

Device Requirements:

The Responsible Person must sight the correct Safe Search measures on the device in order to approve this agreement. Computer devices that are connected to the school's internet (detnsw.net) have an automatic Private DNS, but for iPad and Android devices this is not the case. To ensure Safe Search is enabled, ensure the following has been actioned for the relevant device:

iOS (iPhone, iPad): CleanBrowsing



Information: CleanBrowsing is a DNS-based content filtering service that offers a safe way to browse the web without surprises. It intercepts domain requests and filter sites that should be blocked, based on your requirements. Our free family filter, for example, blocks adult content, while still allowing Google, YouTube, Bing, DuckDuckGo and the rest of the web to load safely. The Family filter blocks adult / obscene content and applies Safe Search filters to Google, Bing,

Yandex, etc. The security filter, however, only focuses on restricting access to malicious activity.

Private DNS (Android):

To turn Private DNS on or off, or change its settings:

1. Open your device's Settings app.
2. Tap Network & internet > Private DNS.
 - If you can't find it, search for "Private DNS." If you still can't find it, get help from your device manufacturer.
3. Select the option:
 - Private DNS provider hostname
 - Enter the Safe Search address:
 - security-filter-dns.cleanbrowsing.org
4. Tap Save.

Student Agreement:

I agree that I will abide by Peak Sports and Learning's **Social Media Device Policy** and that:

- I will not use my mobile phone during Before or After School Care, and it will remain in my bag, or locked safely in the Peak Room.
- I will only use my iPad, tablet, or computer device **during homework time** only with permission and supervision of a Peak Educator.
- I will not take photos of other children with my device.
- I will not use the Peak devices unless permission is given.
- I will stay safe by not giving any personal information to strangers.
- I will have Safe Search activated on my device (CleanBrowsing or Private DNS).
- I will not use **any** device to knowingly search for, link to, access, or send anything that may be found to include content that is considered:
 - Offensive
 - Inappropriate
 - Threatening
 - Abusive
 - Defamatory
 - Bullying
- I will report inappropriate use of a device to the Educator that is supervising the area, or the Responsible Person.
- I acknowledge that Peak Sports and Learning are not responsible for any damage to, or theft of my device.
- Misuse of my device will be dealt with accordingly and will include a potential:
 - Temporary ban of device agreement
 - Termination of device agreement
 - Incident report, which will include a parent notification
- I will only use the following apps/websites/material to develop my learning:
 - Assigned homework, from my teacher
 - Prodigy (a mathematics app)
 - Read Theory (a reading website)
 - Typing Club (a typing development website)

Parent Agreement:

As a parent or caregiver of a student attending Peak Sports and Learning, I understand and support the Social Media Device Policy outlined by the program. I agree to the following (tick):

- I will discuss and review the Peak Sports and Learning Social Media Device Policy with my child to ensure they understand the expectations and rules regarding the use of electronic devices.
- I will ensure that the correct measures are taken to ensure that Safe Search is activated on my child's device. (CleanBrowsing for iOS, PrivateDNS for Android)
- I understand that my child's mobile phone and other electronic devices must remain in their bag or be locked safely in the Peak Room during Before and After School Care, unless explicitly allowed by a Peak Educator for educational purposes during the designated homework times.
- I recognise that the use of devices is limited to specific apps and websites that contribute to my child's learning, and I will encourage my child to use their device responsibly.
- I acknowledge that Peak Sports and Learning is not responsible for any damage to, or theft of my child's device while at the centre.
- I agree to cooperate with Peak Sports and Learning in enforcing any consequences deemed necessary by the educators or staff in response to misuse or inappropriate behaviour regarding device use.
